## Review of Draft Forest Management Plan Pic Forest 2021-2031 Forest Management Plan

The Ontario **Ministry of Natural Resources and Forestry (MNRF)**, **Nawiinginkoima Forest Management Corporation (NFMFC)** and the **Pic Forest Public Consultation Committee (LCC)** invite you to review and comment on the 2021-2031 Draft Forest Management Plan (FMP) for the **Pic Forest**.

### The Planning Process

The FMP takes approximately three years to complete. During this time, five formal opportunities for public consultation and First Nation and Métis community involvement and consultation are provided. The third opportunity (Stage Three) for this FMP occurred on September 24, 2019 to November 24, 2019 when the public was invited to review and comment on proposed operations for the ten year period of the FMP. This 'Stage Four' notice is to invite you to:

- review and comment on the draft FMP; and
- contribute to the background information.

Comments from the public will be considered in revisions to the draft FMP.

Comments on the draft FMP for the Pic Forest must be received by Brian Harbord of the planning team, by **November 13, 2020**.

The last possible date to seek issue resolution with the MNRF Regional Director is **November 28, 2020**.

### Stay Involved

The MNRF-approved FMP will be available for inspection for the 10-year duration of the FMP **Stage Five** - Inspection of the MNRF-approved FMP is tentatively scheduled for **December 2020**.
