## **Mill Trainer (Operations)**

Greenstone Mine is seeking a Mill Trainer to join our team. Reporting to the Senior Training Coordinator, the Mill Trainer is responsible for developing, delivering, and maintaining training materials for the Mill Department with a primary focus in operations.

- Develop mill standard operating procedures in close cooperation with the mill department working as one team

- Evaluate training materials after delivery and revise or update materials as required
- Collaborate with the Mill team to identify and prioritize training needs
- Collaborate with technical personnel to observe and analyze jobs, and validate operating procedures and processes for training purposes
- Deliver training to individuals and groups in the classroom, work areas and as required situations and circumstances
- Plan and optimize training schedules within operational deadlines and track and document employee progress
- Help colleagues perform their jobs safely and effectively by sharing information, skills, and knowledge
- Mentor Operators, evaluating performance to determine level of competency, providing coaching and technical expertise where required
